Application Guide

Surface Preparation

All surfaces must be clean, dry and free of wax, grease, dust and other contaminants. The presence of such contaminats contributes to conditions such as 'rejection' or 'delamination'. If uneven, the surface should be sanded with coarse sandpaper initially. All nail-holes and cracks should be filled with putty, Fine sand the floor, finishing with 100 grit sand paper, then with 100 mesh screen back and vacuum thoroughly.

APPLICATION

Apply a sealer coat of Toby Rapid Seal, prior to application of Lustapol.

Mix equal parts by volume of Lustapol Part A and Part B. Use a graduated measuring jug to ensure an accurate mix ratio.

Apply Lustapol with a soft bristle brush, lambswool applicator or mohair roller. Ensure the application is uniform. Allow first coat to dry for a minimum of 8 hours. Lightly sand with a 100 mesh screenback between coats. Thoroughly remove all sanding dust. Repeat application procedure for the final coat.

RECOATING

Sweep the floor to remove dirt, dust and loose particles. Clean the floor with a pH neutral floor cleaner to remove all traces of grease, grime, etc. Abrade the surface to a dull texture using a 100 grit screenback. Thoroughly remove all sanding dust. Apply one coat of Lustapol as above.

Notes

Toby Lustapol is manufactured to the correct consistency for application by soft bristle brush, lambswool applicator or mohair roller. However, if thickening has occurred due to ageing, thin with up to 10% with Feast Watson Reducer Thinners.

Complete curing of Lustapol takes approxiamtely 7-10 days after application of the final coat, and care must be excercised during this period. Avoid moving chairs or furniture over the surface and use mats in high traffic areas.

To extend the life of the floor, use floor-glides under chair and furniture legs. Sweep the floor regularly and wash periodically with a pH neutral floor cleaner.
